Assumption of Risk, Release & Animal Medical Power of Attorney

There are understandable risks in conditioning dogs and K9C will make every effort to prevent injury to your dog. In the event of a medical emergency involving your dog we will make every effort to contact you. If you are unreachable we will need formal authorization to request medical attention for your dog on your behalf. Please review the following, Thank You.

A: Assumption of risk: I understand and acknowledge that dogs can be extremely unpredictable in behavior and while K9C, performs its programs; there is a chance of injury to my dog. I assume all risks related to K9C services to my dog “with exception to gross negligence” including, but not limited to: illness, bodily injury, death, theft, falls, bites, collisions with vehicles: natural disasters, unavailability of emergency medical care, negligence or deliberate acts of a third party.

B: Release of liability: I agree not to sue and to release from liability K9C, Shawn Sullivan, it’s officers, owners, agents, employees and any other persons or entities involved with the services offered buy K9C, from all actions, claims, or demand for injury, loss or damage regardless of the cause.

C: Indemnification: I understand and acknowledge that dogs can be extremely unpredictable in behavior and may cause damage to third parties for which K9C could be held liable. I agree to bear any and all damages, losses, liabilities, demands and expenses, including legal and professional fees K9C may incur as result of any damage by my pet. I agree to defend and hold K9C harmless from any liability thereon.

It is the intention of the parties top this agreement that the foregoing releases shall be effective as a bar to all actions, fees, damages, losses, claims, liabilities, demands or debts whatsoever, of any nature or kind, known or unknown, suspected or unsuspected, arising out of the performance of K9C services. The parties to this agreement expressly consent that this release shall be given full force and effect in accordance with each and all of it’s express terms and provisions

Animal Medical Power of Attorney

1: I, the undersigned owner, herby designate Shawn Sullivan
And or K9C staff to act as my attorney-in-fact and to act in my name for the emergency medical benefit of my dog upon terms and conditions outlined below.

2: Effectiveness This animal medical power of attorney shall become effective in the case of a medical emergency requiring immediate care for my dog during my absence or if deemed necessary to preserve the life or wellness of my dog.

3: Powers By the execution of this animal medical power of attorney, it is my intention that my attorney-in-fact shall have the authority to make all the emergency health care decisions for my dog to the extent I would, including but without limitation the following: to employ and discharge medical personnel; to execute documents: to provide written consents, releases for treatment: to obtain and administer prescribes medications; and to incur reasonable and necessary fees and costs in caring out the powers and duties under this document, that shall be reimbursed by me upon demand by K9C.

4: Indemnification I shall hold harmless and indemnify my attorney-In-Fact from all liability for acts done in good faith.

I understand that this agreement contains ANIMAL MEDICAL POWER OF ATTORNEY, RELEASE OF LIABILITY AND A CONTRACT BETWEEN K9C, Shawn Sullivan, and me and I am signing this agreement of my own free will. If any part of this agreement is deemed unenforceable, all the parts shall be given full affect to the extent possible. If there is a dispute between the parties relating to this agreement, the party substantially prevailing will be entitled to recover all costs and expenses of any subsequent proceedings (including trial, appellate, and arbitration proceedings), including the attorney fees incurred therein. This agreement contains the complete understanding of the parties with respect to the subject matter hereof and supersedes all prior representations and understandings, whether oral or written. Only writing signed by both parties may modify this agreement.
